Appellate Civil Commitment - The attorney satisfies the Appellate 1 criteria and has either completed four credits of state public defender approved legal education pertaining to chs. 51 and 55, Stats., within the year immediately preceding the application for certification or has been sole trial or appellate counsel of record in five cases under chs. 51 and 55, Stats., in the three years immediately preceding application for certification.
