# **Appellate Spotlight**

Below are some helpful appellate tips for trial attorneys

### How to preserve a client's Right to Appeal

SPD's appellate division has created a cheat sheet which can be found on the website here.

Perfecting the appeal is a two step process: First, at sentencing, attorneys should file form CR-233, the Notice of Right to Seek Postconviction Relief. Please ensure that you obtain a "yes" or "no" from your clients regarding their decision to appeal on the Notice of Rights form. Indicating "undecided" is not a definitive decision regarding an appeal. See Whitmore v. State, 56 Wis. 2d 706, 718–20, 203 N.W.2d 56, 63 (1973), where the court ruled that "the duties of trial counsel should not cease until the decision is made by the defendant and his counsel whether to appeal". Once advised of the right to seek postconviction relief, if the client wishes to appeal, the trial attorney must ALSO file a Notice of Intent to Pursue Postconviction Relief (NOI) form within 20 days after the date of sentencing or final adjudication. See Wis. Stat. Rule 809.30 (2) (a).

The NOI must comply with Rule 809.30 (2) (b) and state

- the date on which the order or judgment from which the appeal is being taken was entered.
- whether the defendant requests SPD representation for appeal,
- whether trial counsel was appointed by the SPD and
- whether the person's financial circumstances have changed.

Trial counsel should email a copy of the NOI and an SPD Appellate Questionnaire, to <u>Madison Appellate</u> intake staff after the NOI is filed.

#### Missed the NOI filing deadline? No problem.

Often, a client may contact a lawyer outside the 20 days and request an appeal. Attorneys should file a motion to extend the 20 day deadline for filing the notice of intent to pursue post conviction relief. Information and form motions can be found on the SPD appellate website here.

### Filing a Writ of Certiorari? Do NOT pay the filing fee.

SPD clients are eligible for waiver of the filing fee. Thus, the SPD does not reimburse this expense. To waive the fee, attorneys should file this form with the court.
